READ BEFORE SIGNING

- 1) There is risk of injury from the activities involved in this program and while particular rules, equipment, and personal discipline may reduce this risk, the risk of serious injury does exist; and,
- 2) I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others, and assume full responsibility for my participation; and,
- 3) I willingly agree to comply with the stated and customary terms and conditions for participation. If, however, I observe any unusual significant hazard during my presence or participation, I will remove myself from participation and bring such to the attention of the nearest official immediately; and,
- 4) I, HEREBY RELEASE AND HOLD HARMLESS Grace Life Church of the Nazarene their officers, officials, agents, and/or employees, other participants, sponsoring agencies, sponsors and advertisers used to conduct the event ("RELEASEES"), WITH RESPECT TO ANY AND ALL INJURY or loss or damage to person or property, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE, to the fullest extent permitted by law.
- 5) Allow Grace Life Church of the Nazarene/New Albany Sand Volleyball to post pictures that may include you and/or your team on its website.
- 6) The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact.
